Lake Center Christian School (LCCS) is open to students interested in securing a Christian education from kindergarten through twelfth grade. The unique mission of Lake Center (assisting Christian families and their churches), allows us to work with students whose parents understand the importance of supporting the school's standards of conduct. We are looking for serious students who are willing to wholeheartedly apply themselves. I Corinthians 10:31 reminds us that we should do everything for God's glory. Students are expected to sign and abide by a "Student Covenant of Accountability." We welcome students who are ready to avail themselves of the privilege of attending a Christian school like LCCS.

CURRENT FAMILIES: Based on our Continuous Enrollment Agreement, the Annual Student Commitment Fee will be billed on January 1st and must be paid by March 1st to ensure continued class placement. If a family withdraws their student after the March 1st deadline, they will still be obligated to pay the non-refundable Annual Student Commitment Fee. Between March 1st and June 1st an additional fee per student will be assessed for withdrawing. After June 1st, the family is obligated to pay 25% of the tuition per student for the coming year.

NEW FAMILY REGISTRATION: All students enrolling at LCCS will be charged a \$50 online application fee. New student enrollment is not considered complete until <u>All References</u> and <u>Student Records</u> (latest report card/transcript, State of Ohio testing scores) have been received, and application has been reviewed and approved by the Admissions Team. All necessary fees and paperwork must be submitted and verified and the <u>Parent Interview</u> completed before acceptance to LCCS.

PAYMENT SCHEDULE: Payments are made over ten months. <u>The first payment is due August 15th</u> and the last payment is due by May 15th. Families who would like tuition payments automatically deducted from their bank account each month should contact the Business Office. If your monthly tuition payments become 90 days overdue, this could jeopardize your student's enrollment at LCCS. All parents are expected to remain current on their tuition payments. Parents who withdraw their children will be expected to pay the remaining tuition and penalties immediately.

REFUND POLICY: Students withdrawing from LCCS after a quarter has started will owe tuition for the full quarter. This amount will be calculated by dividing the total tuition by four. Any unpaid tuition from previous quarters will also be due upon withdrawal. Parents who withdraw their children and still owe a balance on their tuition will be subject to be turned over to collections.

ADDITIONAL FEES: The *Extracurricular Fee Schedule* for athletics/clubs/graduation/mini-terms/music/ special services/before and after school care is available online.
