Please do not let tuition be a barrier to evaluating the Christ-centered education offered at Lake Center Christian School. Lake Center Christian School admits students of any race, color, and national and ethnic origin to all the rights, privileges, programs, and activities generally accorded or made available to students at the school. It does not discriminate on the basis of race, color, or national and ethnic origin in administration of its educational policies, admissions policies, scholarship and loan programs, and athletic and other school-administered programs.



CONTINUOUS ENROLLMENT: The Continuous Enrollment Fee will be billed on January 1st and must be paid by March 1st to ensure continued class placement. If a family withdraws their student after the March 1st deadline, they will still be obligated to pay the non-refundable Annual Student Commitment Fee. Between March 1st and June 1st, an additional fee per student will be assessed for withdrawing. After June 1st, the family is obligated to pay 25% of the tuition per student for the coming year.

REFUND POLICY: Students withdrawing from LCCS after a quarter has started will owe tuition for the full quarter. This amount will be calculated by dividing the total tuition by four. Any unpaid tuition from previous quarters will also be due upon withdrawal. Parents who withdraw their children and still owe a balance on their tuition will be subject to be turned over to collections.

PAYMENT SCHEDULE: Payments are made over ten months. The first payment is due August 15th, and the last payment is due by May 15th. Families who would like tuition payments automatically deducted from their bank account each month should contact the Finance Office. If monthly tuition payments become 90 days overdue, this could jeopardize the student's enrollment at LCCS. All accounts are expected to remain current on payments. Parents who withdraw their children will be expected to pay the remaining tuition and penalties immediately.

NEW STUDENT REGISTRATION: Students applying to enroll at LCCS will be charged a one-time, \$50 online application fee. In addition to the online application, all required documents, referrals, and records must be reviewed and approved by the Admissions Committee. Screening and a family interview may need to be completed. Accepted students will receive an official notification from the school. Should the applicant student accept the enrollment invitation, the parent will complete the enrollment forms, LCCS will request official school records from the previous school (if applicable), and parents may begin the desired scholarship application process.

SCHOLARSHIPS AND TUITION ASSISTANCE: LCCS accepts Ohio Ed Choice scholarships, Jon Peterson scholarships, and OCEN SGO scholarships. We will help you through the applicable scholarship application processes for your family.
